District 7 Executive Board Meeting, Tuesday, -September 7, 2021

President Alice Beers called the meeting to order at 10:05 a.m. at 7 Hills.

Present: Alice Beers, Jeannie Gregory, Janet Langemeier, Harlan Mathews, Carol Anderson, George Hayner, Suzanne Shapiro and Howard Harrell

Secretary's Report: Motion was made to accept the minutes of the June 22, 2021, Ex. Board Meeting. Second and approved.

Treasurer's Report: Harlan stated he will have a list of District 7's transactions at the upcoming President's Meeting.

Old Business:

Reminder of masks and lunches: With League play beginning in October we were reminded that players are asked to bring their own lunch. Teams may provide water and coffee. Lunch should take approximately 15-20 minutes. Suzanne stated she is aware of a caterer that has offered to make lunch for teams. If your team is interested you can get further info from Suzanne.

1. With the resignation of Lynda Goggin from the Executive Committee a new committee member will be voted on at the President's Meeting this Saturday. Please let Jeannie know of Shufflers that would like to have their name on the ballot for this position which will run until the May President's Meeting.

Suzanne stated she is interested in working with Lynda to see how the yearly Membership Directory is completed. She will contact Lynda.

2. Method for drawings for tournament play: CSA rules have been followed for CSA tournaments. Discussion followed on the possibility of putting all names in a hat; #1 Name drawn would be on first line, #2 Name drawn goes on 2nd line, etc. CSA tournaments must be seeded according to CSA rules which read differently. Some tournaments such as Hemet Muni Bonspiel, may follow blind draw because it is not a CSA tournament. It was decided to try the Blind Draw with the Oldlympics this fall. This will be put on the agenda for the upcoming President's Meeting.

3. Picnic: Janet reminded us of the upcoming picnic at Four Seasons on Friday, Oct. 1st. Dashboard signs will be available for Presidents to pick up at Saturday's meeting. All sign up sheets and \$5 per person needs to be turned in at the Presidents meeting on Saturday. We're looking for donations of water/soda to be used at picnic. After discussion a motion was made and passed to use \$200 (savings from not having band) for our raffle at the picnic.

4. Oldlympics: George has been getting Muni ready to host the Oldlympics in Sept. Remember we need help with referees and scorekeepers.

5. Possible 3 court play for next year or maybe 3 divisions. Because of our numbers getting lower we will be looking at going to 3 divisions for next year (2022-23). Alice will mention this at the President's meeting.

Another idea was discussed: have 20 Teams (10 A Teams & 10 B Teams) playing. Changes are coming because our number of players is dropping each year.

6. Betty Elias stated the Red Division Traveling plaque that was at SDSE is missing. The question was brought up about not having a Red Team Traveling Trophy. This will be discussed at the President's meeting.
