- #5 No Div. #1 players can be used as Subs in Div. #2 or #3
- #6 Div. #1 can pull Subs from Div. #2 or Div.#3
- #7 Div. #2 will pull Subs from Div. #3
- #8 Div. #3 will pull Subs from Div. #2

Numbers #2 and #3 will help minimize the use of sub's. Last season we used 117 Sub's with 1 venue using 81 of the 117

"OPTION" Each team players only 3 Boards then you could have 8 players min. #2 and #3 above will be applied here as well.


