1. Hall of Fame CSA Any Singles: Date for 2024: Feb. 26-29, 2024. All agreed to the date.
2. Ray Paterson Kick-Off Picnic: Fall Picnic for 2023-24 was discussed. Janet will check with Hamilton Jones to see if Mortuary will provide lunch. Other discussion followed on some different entertainment ideas for the picnic.
3. Three Divisions: Substitutes for League Play next fall:
