District 7 Executive Board Meeting, Tuesday, January 4, 2022

President Alice Beers called the meeting to order at 10:00 a.m. at 7 Hills.

Alice, Jeannie and Howard will not remain on the board for next year.

Alice volunteered to be Committee Chairperson for Election Committee.

Carol Blasingame brought it to our attention, that to her knowledge, a Rookie that has played in a tournament will not be eligible for the Rookie Tournament. There is nothing in writing stating the matter. Jeannie emailed Sharyn DiChiro who is a past president and past Tournament Director for any information on the subject. Sharyn replied that "They considered a Rookie a person that had played only one year prior to the start of the Rookie Tournament even if the person had won in a prior tournament. The time frame was the only qualification.

Jeannie is inserting a page with the Rookie Qualifications to the CSA Tournament regulations with the above said qualification..

Referees and Scorekeepers will be used in the Rookie Tournament. Alice will send an email to Presidents asking how many Rookies they have for this year.

It was voted on and passed unanimously to add the 10-minute Rule to our District 7 Rules.

If you do not have 8 players to start play there will be a 10-minute waiting time for players to show up. If after the 10 minutes have passed the team with the shortage will play and the opposing team will get 2 pts for the game that doesn't have a player and any subsequent games that are played with less than 8 players. They may use a pusher.

At the upcoming President's Meeting Alice will be asking for suggestions on how to structure the league next year if we don't get more new players. Alice will ask for volunteers for the Election Committee.

Ron Dewberry and Janet Langemeier met with Louise Salscheider on Saturday and reported that Louise was receptive to the suggestions about rules.

Howard motioned to adjourn the meeting; Jeannie seconded the motion.
