Approval of Minutes: Motion was made to approve minutes of June 25, 2022. Seconded and passed.
Upcoming League Season: Jack Anderson spoke on items having to do with the upcoming League Season. The following are items that were discussed:

1. Upcoming League Season: Wednesday, October 5th (Division 1) and Thursday, October 6th (Division 2) will begin play. With the usual breaks for Thanksgiving and Christmas/New Year Holidays, the Season will be ended on Feb. 22nd (1st division) and Feb. 23rd (2nd division).
2. A suggested starting time for League Play is 11 a.m.
3. Jack spoke on organization of the two divisions. We have 18 teams for this season. He stated that we have 10 teams in Div. I and 8 teams Div. II. This will cause Div. II league play to end before Div. I. the following decision was made: The last team in the White Division last year will be asked to change to Division II so all teams end on the same week.
4. The Champions Tournament will be held on Feb. 27th-28th, 2023 and the Rookie Tournament will be played on March 1st and 2nd, 2023. The Annual Soboba Classic dates for next year are March 27th (Orientation) with play starting on March 28th-31st.
5. All Tournaments to be held in the spring/summer of 2023 need to be approved in October.
6. It is suggested that a light lunch be served by the Home Team for league play. If the Home Team isn't serving lunch all players must provide their own lunch.
7. Suzanne Shapiro (Division 1) and Carol Anderson (Division 2) will be keeping track of players that are willing to sub. Players are asked to let them know if you are willing to sub. Division 1 players will sub for Division 2; Division 2 players will sub for Division 1.
