Minutes of the January 4, 2022: Executive Board Meeting minutes were approved as written.

Treasurer's Report: No report.

<u>Election Process</u>: It was discovered that the Board President cannot serve on the Nominating Committee. Carol Anderson and Howard Harrell agreed to serve this year on this committee. This year we have three Club Presidents who also serve on the D7 Board. A question was asked about this situation. Harlan stated this is dealt with in the D7 Bylaws-Article IV-District Board. It was decided a message will go out to Club Presidents to report in a couple weeks the number of teams and players they are projecting for next season. A President's meeting is scheduled to take place on Saturday, June 4<sup>th</sup>, at SDSE at 10 a.m. to discuss this issue.

## Other Discussion:

<u>Bonspiel</u>: The Bonspiel Tournament at Hemet Muni is scheduled for June 6-8. Exactly 64 players are needed for this tournament. Sign Up sheet was available for Board Members.

<u>Boyajian Award</u>: Carol Anderson spoke about this yearly award that is given to two District 7 Shufflers at our Awards Ceremony in April. She is concerned that the attendance isn't as good as it could be at this event. This means winners do not get the recognition they deserve. This issue will

be discussed further at an upcoming meeting.
